

Purpose

The purpose of this policy and procedure is to outline Australian Virtus Institute's approach to managing dissatisfaction, formal complaints and appeals of students, clients, staff and other members of the community. It provides a transparent approach for all complaints and appeals to be addressed in a fair, efficient and confidential manner.

This policy and procedure ensure compliance with Standard 6 of the Standards, as well as compliance with the of the National Code of Practice for Providers of Education and Training to Overseas Students 2018, Standard 10.

Definitions

ASQA means Australian Skills Quality Authority, the national VET regulator and the RTO's registering body **Appeal** means a request for a decision made by Australian Virtus Institute to be reviewed

DET means Department of Education and Training

Complaint means a person's formal expression of dissatisfaction with any product or service provided by Australian Virtus Institute.

PRISMS means Provider Registration and International Students Management System

Overseas Student means someone who is studying in Australia on a student visa. An overseas student is also called an international student.

Services means training, assessment, related educational and support services and/or activities related to the recruitment of prospective learners. It does not include services such as student counselling, mediation or ICT support

Standards means the Standards for Registered Training Organisations (RTOs) 2015 from the VET Quality Framework

 - The RTO, its trainers and assessors and other staff.
 - Any third-party providing Services on behalf of Australian Virtus Institute and including education agents.
 - o Any student or client of Australian Virtus Institute.
- Complaints may be made in relation to any of Australian Virtus Institute's services and activities such as:
 - the application and enrolment process
 - o marketing information
 - o the quality of training and assessment provided
 - training and assessment matters, including student progress, student support and assessment requirements
 - $\circ \quad$ the way someone has been treated
 - o the actions of another student
- An appeal is a request for a decision made by Australian Virtus Institute to be reviewed. Decisions may have been about:
 - $\circ \quad \text{course admissions} \quad$
 - refund assessments
 - response to a complaint

2. Principles of resolution

- Australian Virtus Institute is committed to developing a procedurally fair complaints and appeals process that is carried out free from bias, following the principles of natural justice. Through this policy and procedure, Australian Virtus Institute ensures that complaints and appeals:
 - Are responded to in a professional, consistent and transparent manner. 0
 - Are responded to promptly, fairly, objectively, with sensitivity and confidentiality. 0
 - Are able to be made at no cost to the individual. 0

- Are used as an opportunity to identify potential causes of the complaint or appeal and take actions to 0 prevent the issues from recurring as well as identifying any areas for improvement.
- Australian Virtus Institute will inform all persons or parties involved in any allegations made as well as providing them with an opportunity to present their side of the matter.
- There are no charges for students to submit a complaint or appeal to Australian Virtus Institute, or to seek information or advice about doing so.
- Nothing in this policy and procedure limits the rights of an individual to take action under Australia's . Consumer Protection laws and it does not circumscribe an individual's rights to pursue other legal remedies.

Making a complaint of appeal 3.

- Complaints about a particular incident should be made as soon as possible after the incident occurring and appeals must be made within thirty (30) calendar days of the original decision being made.
- Complaints and appeals should be made in writing using the Complaints and Appeals Form, or other . written format and sent to Australian Virtus Institute's head office at 50 Grenfell St, Adelaide SA 5000 attention to the Chief Executive Officer.

When making a complaint or appeal, provide as much information as possible to enable Australian Virtus Institute to investigate and determine an appropriate solution. This should include:

- The issue you are complaining about or the decision you are appealing describe what happened 0 and how it affected you.
- Any evidence you have to support your complaint or appeal. 0
- Details about the steps you have already taken to resolve the issue. 0
- Suggestions about how the matter might be resolved.

Timeframes for resolution 4.

- The complaint or appeal will be acknowledged in writing within 3 business days.
- The complaints and appeals process will commence within 10 business days of receipt of the application. Complaints and appeals will be finalised as soon as practicable or at least within 30 calendar days unless there is a significant reason for the matter to take longer.
- In matters where additional time is needed, the complainant or appellant will be advised in writing of . the reasons and will be updated weekly on the progress of the matter until such a time that the matter is resolved.

5. Resolution of complaints and appeals

- Some or all members of the management team of Australian Virtus Institute will be involved in resolving complaints and appeals as outlined in the procedures.
- Where a complaint or appeal involves another individual or organisation, they will be given the • opportunity to respond to any allegations made.
- Where a third-party delivering Services on behalf of the RTO is involved, they will also be included in the process of resolving the complaint or appeal.

SC4: Complaints and Appeals Policy & Procedure

- Each party involved in the complaint or appeal may have a support person of their choice present at meetings scheduled to resolve the issue.
- In the case of an assessment appeal, an assessor who is independent from the original decision will
 assess the original task again. The outcome of this assessment will be the result granted for the
 assessment task. The complainant or appellant will be advised in writing of the outcome of the process
 and the reasons for the findings made.

- For domestic students that choose to access this policy and procedure, Australian Virtus Institute will maintain the student's enrolment while the complaints and appeals process is ongoing.
- For international students, Australian Virtus Institute will maintain a student's enrolment throughout the internal appeals processes without notifying DET via PRISMS of a change in enrolment status. In the case of an external appeals process it will depend on the type of appeal as to whether Australian Virtus Institute maintains the student's enrolment as follows:
 - If the appeal is against Australian Virtus Institute's decision to report the student for unsatisfactory course progress or attendance, the student's enrolment will be maintained until the external process is completed and has supported or not supported Australian Virtus Institute's decision to report.
 - If the appeal is against Australian Virtus Institute's decision to defer, suspend or cancel a student's enrolment due to misbehaviour, Australian Virtus Institute will notify DET via PRISMS of a change to the student's enrolment after the outcome of the internal appeals process

6. Independent Parties

- Australian Virtus Institute acknowledges the need for an appropriate independent party to be appointed to review a matter where this is requested by the complainant or appellant and the internal processes have failed to resolve the matter. Costs associated with independent parties to review a matter must be covered by the complainant/appellant unless the decision to include an independent party was made by Australian Virtus Institute.
 - For international students, the independent party is the Overseas Students Ombudsman. This service is free of charge. Where an international student is not satisfied with the outcome or conduct of the internal process, they are referred to the Overseas Students Ombudsman (OSO).  - All other complainants or appellants can find an appropriate independent party by calling the Resolution Institute on 02 9251 3366 or by searching the following directory, according to locality and area/s of concern: <u>https://www.resolution.institute/disputeresolverdirectory</u>
 - Australian Virtus Institute will provide complete cooperation with the external mediator investigating the complaint/appeal and will be bound by the recommendations arising out of this process.
 - The CEO will ensure that any recommendations made are implemented within twenty (20) days of being notified of the recommendations. The complainant or appellant will also be formally notified in writing of the outcome of the mediation.

7. External complaint avenues

- Complaints can also be made via the following avenues:

 - The National Training Complaints Hotline is a national service for consumers to register complaints concerning vocational education and training. The service refers consumers to the appropriate

Australian Skills Quality Authority (ASQA):

Complainants may also complain to Australian Virtus Institute's registering body, Australian Skills Quality Authority (ASQA).

ASQA can investigate complaints about Australian Virtus Institute in relation to:

- the quality of our training and assessment
- our marketing and advertising practices

ASQA may not be able to investigate complaints if you do not include evidence that you have already exhausted Australian Virtus Institute's formal internal complaints process as above.

<u>The Overseas Student Ombudsman (OSO)</u>

International students may complain to the OSO if their complaint is in relation to Australian Virtus Institute:

- refusing admission to a course
- course fees and refunds
- course or provider transfers
- course progress or attendance
- cancellation of enrolment
- accommodation or work arranged by your provider
- incorrect advice given by an education agent.
- if you believe we have failed to take action or are taking too long to take some action. This might include (for example), failing to provide your results in the normal timeframe, or failing to provide services included your written agreement with Australian Virtus Institute.
- The OSO may not be able to investigate your complaint if you have not already exhausted our formal internal complaints process as above.

•	The CEO should review all complaints upon receipt.	
•	Acknowledge receipt of complaint in writing by sending a letter to complainant within 3 working days of receipt. Use <i>Complaint/ Appeal Acknowledgement Letter</i> .	
•	Record details of the complaint on the Complaints and Appeals Register.	
•	Commence process of investigation within 10 days of receiving the complaint.	
в.	Investigate the complaint	CEO
•	Upon receiving the complaint, the matter is to be investigated to ensure all relevant information is available and it is accurate and complete.	
•	Further details from the complainant, respondent or other involved parties may be requested during this stage. This may be in writing, over the phone, or face-to-face. Where the meeting is face to face, the complainant may be accompanied by a support person.	
•	If the matter is in relation to a third-party delivering Services on behalf of the RTO, the third party should be involved in the resolution of the complaint.	
•	The investigation will also identify corrective and preventative action which will be immediately implemented as per the next section of this procedure.	
•	The CEO will review the information and decide on an appropriate response. Where deemed necessary by the CEO, the matter may be reviewed by other members of the management team to arrive at an appropriate resolution.	
•	Note: The complaint must be completely resolved within 30 calendar days of receipt of the original complaint. If the matter is particularly complex and it is going to take longer to resolve, the complainant is to be advised in writing along with reasons for the extra time. They must be provided with updates on progress on a weekly basis thereafter until the matter is resolved.

•	Upon receipt of a request for an appeal, acknowledge receipt of appeal in writing by sending a letter to appellant within 3 working days of receipt to ensure appellant receives it within 7 days. Use <i>Complaint/Appeal Acknowledgement Letter</i> .		
•	Record details of appeal on the Complaints and Appeals Register.		
В.	Respond to assessment appeals	CEO, RTO Manager	
•	In the case of appeals against assessment decisions, the original assessment decision will be reviewed by having an assessor independent of the original decision, mark the assessment task again.		
•	The assessment decision made during the appeals process will be considered the actual assessment outcome for the task.		
•	Advise the student of the outcome of the appeal.		
C.	Respond to appeals against non-academic decisions	Management team	
•	Upon receiving the appeal, the matter is to be investigated to identify the original decision made and the reasons for the decision.		
•	Further details from the appellant, respondent, the person who made the original decision, or other involved parties may be requested during this stage. This may be in writing, over the phone, or face-to-face.		
•	If the matter is in relation to a third-party delivering Services on behalf of the RTO, the third party should be involved in the resolution of the appeal.		
•	The appellant may request for an independent party (mediator) to be involved in the process. Where this is requested by the appellant, they will bear the costs associated. Additionally, Australian Virtus Institute may decide to call upon an independent mediator to assist to resolve the issue where a decision		





 Australian Virtus Institute's Management team will review all relevant information and decide on an appropriate response. The investigation will also identify corrective and preventative action, which will be immediately implemented as per the next section of this procedure.
